DESCRIPTION

SikaControl®-3760 WT hydrophilic crystalline powder admixture which becomes an integral part of concrete and is used to produce waterproof concrete. It is designed for use in above-grade and below-grade applications.

SikaControl®-3760 WT consists of portland cement, very fine treated silica sand and various active, proprietary chemicals. These active chemicals react with the moisture in fresh concrete with the by-products of cement hydration to cause a reaction, which generates an insoluble crystalline deposit throughout the pores and capillary tracts of the concrete. SikaControl®-3760 WT reduces water permeability of concrete structures and improves self-healing property in presence of moisture.

Suitable to use in hot and tropical climatic conditions.

USES

SikaControl®-3760 WT can be used in all structural concrete that is constantly or intermittently in contact with water such as sea walls, tunnels, basements, structural and pre-cast concrete. SikaControl®-3760 WT can also be used as crystalline waterproofing admixture for cement mortars and plasters. SikaControl®-3760 WT can be used to waterproof structures such as:

- Building basement and foundations
- Sewage and water treatment plants
- Dams, canals, tunnels, harbours
- Tunnel and subway systems
- Water reservoirs
- Concrete pipes
- Parking structures

TECHNICAL INFORMATION

Concreting guidance	 Points to remember when producing waterproof concrete: Ensure water / cement ratio is less than 0.5 Addition of superplasticiser from the Sikament[®], SikaPlast[®] or Sika[®] ViscoCrete[®] range is advised to achieve minimum water/cement ratio. Good concrete practice as per ACI standards regarding mixing, placing and curing. Use Sika[®] Antisol[®] products as a curing agent or apply wet hessian.
Effect on setting	SikaControl®-3760 WT admixture has minor to no effect on concrete set- ting time within the recommended dosage range. However, it is recom- mended to test this in case any additives or blended cementitious combin- ations are used.

APPLICATION INFORMATION

Recommended dosage	 1 % by weight of binder. Dosage up to 2 % by weight of binder can be used depending on the mix design, raw materials, climatic conditions and concrete requirements. To ready mix concrete, a typical dosage of 5 kg per cubic meter of concrete is recommended. However, the optimum dosage to meet project requirements must be determined through trial mixes.
Dispensing	SikaControl®-3760 WT should be added within the recommended dosage. It may be batched in either a central or truck mixer. Follow the procedures outlined in ASTM C94 / C94M, Standard Specifica- tion for Ready-Mixed Concrete, for general batching and mixing instruc- tions for concrete if adding to a truck mixer. Provide at least 5 minutes of mixing after the addition of SikaControl®- 3760 WT admixture to ensure thorough and uniform distribution of the ad- mixture in the concrete mixture.
Compatibility	SikaControl®-3760 WT is suitable for mixes containing all types of cement and supplementary cementitious materials such as Microsilica (Silica Fume), Fly Ash (PFA), GGBS (ground granulated blast furnace slag) and the following Sika products: SikaPlast®, Sika® ViscoCrete®, Sikament®, Plastiment®, SikaPump®, Sika® FerroGard®, SikaFume®, SikaFiber®, Sika® Aer, Sika® Stabilizer, SikaCon- trol® We recommend to perform trial mixes to establish the required perform- ance when combining SikaControl®-3760 WT with the above products or other admixtures. In all concrete application, Sika-Control®-3760 WT will conform to the most stringent or minimum chloride ion limits currently suggested by construction industry standards and practices. SikaControl®-3760 WT has minor or no effect on workability of concrete. Prior site trials are advised to assess the effect and any increase or decrease in the workability can be adjusted by adjusting the admixture dosage or amount of water in use.

It is strongly recommended that concrete should be properly cured particularly in hot, windy and dry climates.
